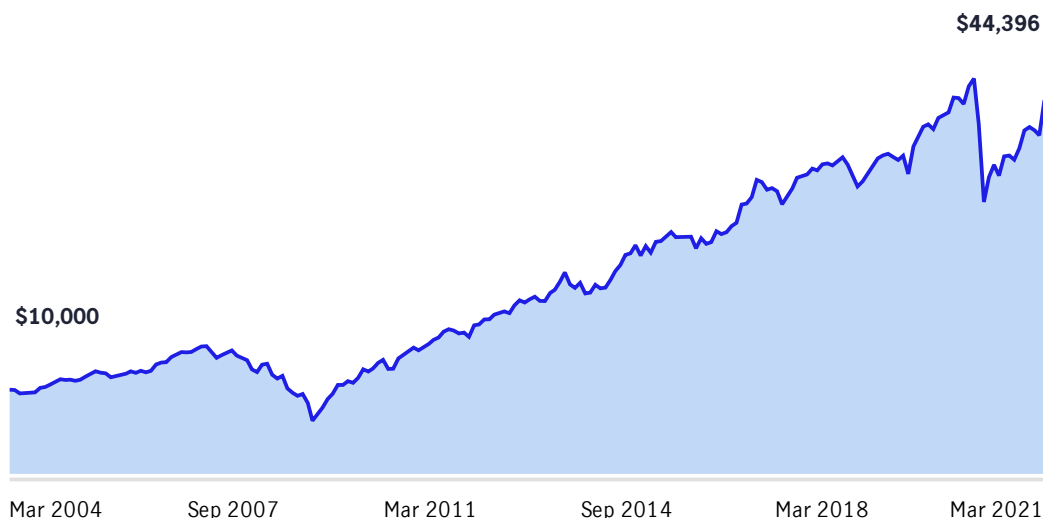

Growth of a hypothetical \$10,000 investment

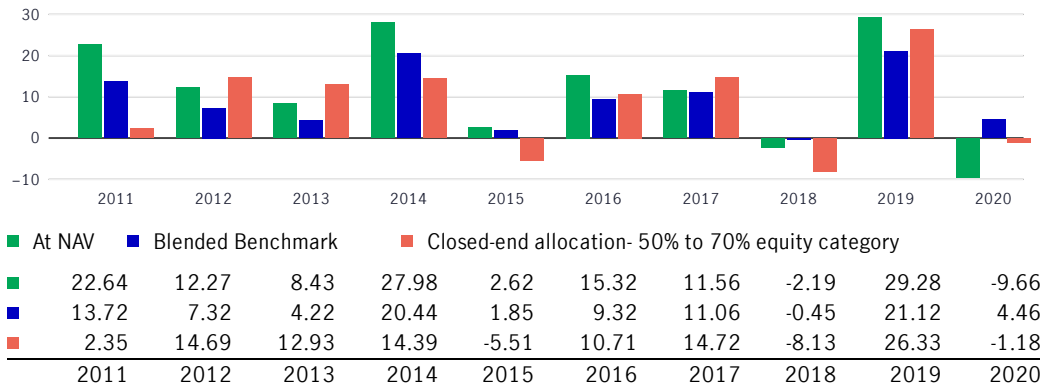

Calendar year returns %

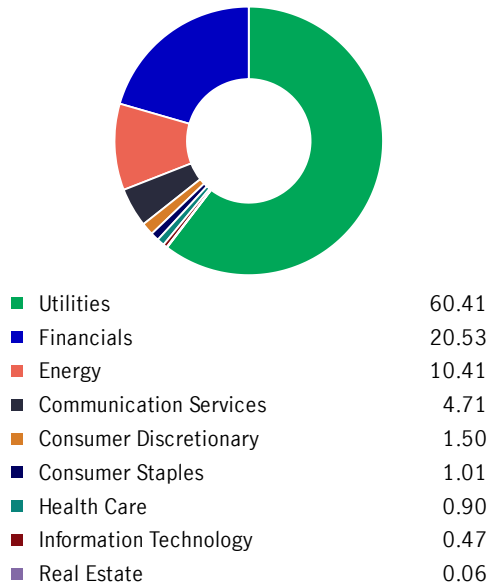

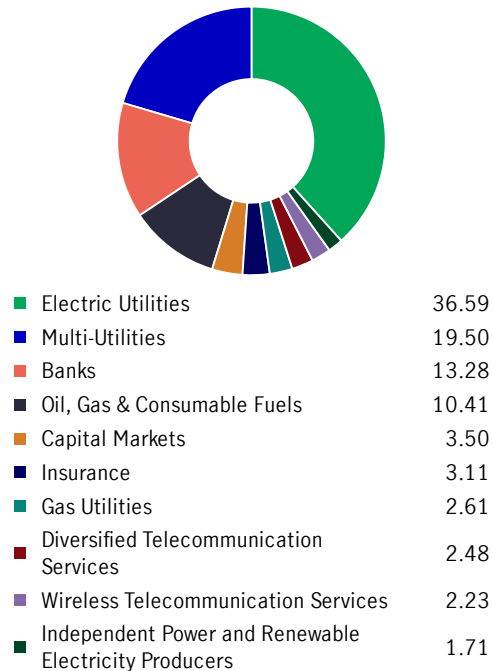
